About the Town of Weare Ethics Committee.

1. What is the Weare Ethics Committee and what does it do?

The Town of Weare Ethics Committee is a committee of 5 townspeople who have been elected at town meeting to support the Town of Weare Code of Ethics (attached below and available in paper copy at Town of Weare Clerk's Office) through providing education, advice, and a process to hear and decide complaints from townspeople regarding ethical issues.

2. Who does the Weare Code of Ethical Conduct apply to?

The Weare Code of Ethics, attached above, was adopted through town vote in March of 2006. This Code, which describes a set of standards of behavior that its leaders and staff should aspire to, is signed by and applicable to all Town of Weare employees, as well as elected and appointed officials. This list includes Town of Weare Board of Selectman, as well as the boards and committees listed here:

3. I think I have an ethics question, but I am not sure who to talk to about it or what steps I should take. Is there someone I can consult with, or a process??

In general terms, The Town of Weare Ethics Committee can address ethics issues in 3 ways: A general ethics question or concern can be brought forward anonymously, in writing to the committee through an established process (see attached) and the committee can provide general opinion and guidance at our regularly scheduled meetings.

A general ethics question can be brought forward in writing to the committee through an established process (see attached) and the committee can be asked for a Written Advisory Opinion, which they will render.

A specific ethics complaint can be brought to the committee, in writing using the established process (see attached) and the ethics committee can provide a formal hearing process for the complaint, with a finding.

Only residents of the Town of Weare can avail themselves of Ethics Committee services. There are other requirements to using each of these options that are outlined in the procedure document attached above.

4. Are Ethics Committee opinions the same as legal rulings?

No. Ethics Committee opinions, advise and outcomes are not the same as legal rulings, and are only advisory in nature.
